Since July 1st 2015 all clients staying in a hotel, residence or aparthotel (e.g.: Adagio residences) in Paris have to pay an occupancy tax. This tax is per night and per person, it can't be paid in advance and has to be paid at the reception on arrival.

SUMMER RESIDENCES (JULY AND AUGUST)

This tax is per night and per person (this means that a family of 3 booking an Adagio aparthotel will have to pay three times that tax every night). It can't be paid in advance and it has to be paid at the reception on arrival.
